- 3A. What theoretical tools are most appropriate for understanding the impact of globalization on international politics?

- 5B. "Signaling of intentions rarely is effective--indeed the very fact that a state has to signal what it will do means that it knows that others have reason to think that it will act otherwise." Discuss.
